**Revoke Directions under Section 5 of the Environment (Protection) Act, 1986**

**WHEREAS**, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

**WHEREAS**, the tannery and leather industries are also identified as one of the Grossly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Water and Air, having potential to threat to cause adverse effects on the water and air quality; and

**WHEREAS**, M/s Ahtesham Leather & Leather Product, (Old Name: Nasir ki Tannery), Jajmau, Kanpur (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 04.04.2017 to verify the compliance status; and

**WHEREAS**, CPCB issued closure direction on dated June 19<sup>th</sup>, 2017 under Section 5 of Environment (Protection) Act, 1986 to the unit ; and

**WHEREAS**, unit's replies vide letters dt.10.07.2017, 15.08.2017, & 26.08.2017 were examined and following observations made.

1. The unit submitted details of registration of the OCEMS with the CPCB portal and provided the connectivity with CPCB server.
2. The unit has submitted copy of the valid consents till 30.6.2017 and has applied for the consents under the Water and Air Acts.

3. The unit is engaged in manufacturing of finished leather from split leather.
4. The unit has installed screens in effluent carrying drains, installed 200 litres drum in the settling tank to enhance settling time and increased chemical dosing for improved PETP performance.

**AND NOW, THEREFORE,** in view of the above observations and in exercise of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the closure direction dated June 19<sup>th</sup>, 2017 is hereby revoked and the unit is directed to comply with the following.

The unit shall ensure proper operation of ETP so as to achieve the prescribed standards and continuous transmission of data to CPCB.

In case of default in compliance with the above directions or any other exigencies, CPCB will be constrained to initiate further stringent action against the unit (**M/s Ahtesham Leather & Leather Product, (Old Name: Nasir ki Tannery), Jajmau, Kanpur**) in accordance with the provisions of the Environment (Protection) Act, 1986, without any further notice.
