Directions Under Section 5 of the Environment (Protection) Act, 1986

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No.S.O.157(E) of 27.02.1996 and S.O.730(E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, the tannery and leather industries are also identified as one of the 17 categories of highly polluting industries which have been discharging environmental pollutants directly or indirectly in to ambient Air and Water, having potential to threat to cause adverse effects on the water and air quality; and

WHEREAS, M/s, Naaz Leather Finishers, 14-A, 150 Feet Road, Jajmau, Kanpur, Uttar Pradesh (hereafter referred to as the 'Unit') is a Tannery industry and was inspected by a team of officials authorized by CPCB on 13.04.2017 to verify the compliance status; and

WHEREAS, CPCB issued Show cause notice dated 28.06.2017 under section 5 of Environment (Protection) Act, 1986 to the unit; and

WHEREAS, unit replied vide letter dated 11.07.2017 in respect of show cause notice and stated that:

1. Unit has proper connectivity with CPCB server.
2. Unit has proper registration on Industry portal of CPCB.
3. Unit replied that PETP has been upgraded according to the prescribed norm.

WHEREAS, the reply details were examined and observed that the unit has proper registration; and

AND NOW, THEREFORE, in view of the above observations and in exercise

of the powers, delegated to the Chairman, CPCB under section 5 of the Environment (Protection) Act, 1986, the show cause notice dated 28.06.2017 issued to M/s Nazz Leathers Finishers, 14-A, 150 Feet road, Jajmau Kanpur, Uttar Pradesh is hereby revoked and directed to comply with following directions:

- 1) The Unit shall provide continuous OCEMS data connectivity on CPCB server.
- 2) The Unit shall comply with consented conditions as issued by UPPCB.

In case of default in compliance with the above directions CPCB will be constrained to initiate appropriate actions against the unit, without giving any further notice, in accordance with provisions of Environment (Protection) Act, 1986.
