**DIRECTION UNDER SECTION 5 OF THE ENVIRONMENT (PROTECTION) ACT,
1986**

WHEREAS, the Central Government has notified the standards for discharge of environmental pollutants from various categories of industries under the Environment (Protection) Act, 1986 and the rules framed there under; and

WHEREAS, the Ministry of Environment & Forests, Government of India, vide Notifications No. S. O. 157 (E) of 27.02.1996 and S. O. 730 (E) dated 10.07.2002, has delegated the powers vested under Section 5 of the Environment (Protection) Act, 1986 (29 of 1986) to the Chairman, Central Pollution Control Board, to issue directions to any industry or any local body or any other authority for violations of the standards and rules notified under the Environment (Protection) Rules, 1986 and amendment thereof; and

WHEREAS, obligatory on the part of industries to install effluent treatment plants (ETPs) to comply with the effluent discharge standards as notified the Environment (Protection) Act, 1986 and the rules framed there under and also to meet the consent conditions granted by State Pollution Control Board (SPCBs)/Pollution Control Committees (PCCs); and

WHEREAS, there is a need to inculcate habit of self-monitoring within the industries for complying with the prescribed standards and this can be achieved by the methods like installing online effluent and emission monitoring devices; and

WHEREAS, for strengthening the monitoring and compliance through self monitoring mechanism, online source emission and effluent monitoring systems need to be installed and operated by the industries on 'Polluter Pay Principle'; and

WHEREAS, M/s Alig Industries, Fact. & H.O.: 36, A-Block, 150 ft. Road, Jajmau, Kanpur, U.P. (hereafter referred to as the 'Unit') was inspected on 28.03.2017 by team of officials authorized by CPCB; and

WHEREAS, CPCB issued show cause notice under section 5 of the Environment (Protection) Act, 1986 dated 21-06-2017 to the unit for incomplete registration of Online Continuous Effluent Monitoring system with CPCB server; and

WHEREAS, the Unit's reply vide letter dated 19-07-2017 was examined and following observations are made:

1. The unit has completed registration of OCEMS on CPCB portal.

AND NOW THEREFORE, in view of the above mentioned observations and in exercise of the powers delegated to the Chairman CPCB, under section 5 of the Environment (Protection) Act, 1986, the unit's show cause notice dated 21.06.2017 is revoked herewith and the unit is directed to comply with the following direction:

1. The Unit shall operate ETP properly so as to ensure compliance with the effluent discharge norms notified under Environment (Protection) Act, 1986. At any stage, if the treated effluent does not meet notified discharge standards the unit shall close down manufacturing operations immediately and report to CPCB.
2. The unit shall ensure continuous connectivity with CPCB server.

In case of default in compliance with the above directions, CPCB will be constrained to initiate action against the Unit namely **M/s Alig Industries, Fact. & H.O.: 36, A-Block, 150 ft. Road, Jajmau, Kanpur, U.P.** in accordance with the provision of the Environment (Protection) Act, 1986, without giving any further notice.
