Subject: E-waste(Management) Rules, 2022 – regarding release of imported consignments of producers of 85 EEE items (ITEW17 to ITEW27, CEEW6 to CEEW19, LSEEW1to LSEEW34, EETW1 to EETW8, TLSEW1 to TLSEW6, MDW1 to MDW10 and LIW1 to LIW 2) – reg.

Sir,

This has reference to your Office Memorandum F.No. 401/03/2023 - Cus III dated 21-04- 2023 on the above mentioned subject. The point wise clarifications are as below:

- The interim arrangements as proposed vide letter of even no. dated 13-04-2023 will be till 30-06-2023. Afterwards the release of the consignments should be done only upon submission of EPR Registration Certificates of Producer from the Concerned EPR Portal.
- The Number of days for consideration of time period shall be counted from the date of submission of undertaking to customs. The Concerned Producer may submit bill of entry along with the undertaking. The Number of days, for submission of EPR Registration Certificate of producers from the date of undertaking, now be considered till 30-06-2023 instead of 30 days as communicated vide CPCB letter even no. dated 13-04-2023.
- CPCB is keeping record of the undertakings that have been submitted by the concerned Producers for release of their imported consignment. In this regard, kindly provide point of contact for providing the status of compliance.

In addition to above, it is also requested that imported consignments of producers of 21 EEEs Item (ITEW1 to ITEW16 & CEEW1 to CEEW5) whose Extended Producer Responsibility Authorisation (EPRA), issued under the E-Waste (Management) Rules, 2016, has expired may be released if they submit an acknowledgement from the CPCB's EPR Portal that they have applied at the EPR Portal along with the copy of the EPRA whose validity is over. This arrangement should also be continued till 30-06-2023.
