**OFFICE ORDER**

The case for removal of anomaly in the pay structure of Administrative cadres was placed before the Board in its 175<sup>th</sup> Meeting held on 21 December, 2016 vide Item No. 3.19. The Board deliberated the matter and resolved that necessary follow up action in the matter be taken in strict compliance with the directions of the Hon'ble Supreme Court. It was also resolved that benefit be extended to only those employees who were to be given benefit as per the order of the Hon'ble Court but were not extended such a benefit.

Subsequent to the Resolution passed by the Board based on the Order passed by the Hon'ble Courts, the Competent Authority in CPCB also sought the legal opinion. The approval of the Competent Authority, CPCB is hereby conveyed for placing the petitioner Section Officers and Private Secretaries only in the pay structure of grade pay of Rs.4800/- in PB-2 w.e.f. 01.01.2006 and grade pay of Rs.5400/- in PB-3 on completion of 4 years of regular service in the cadre. Accordingly, the pay of Section Officers and Private Secretaries mentioned in the enclosed annexure is hereby revised and re-fixed. The MACP(s) granted to any of the employee mentioned in the enclosed annexure after 01.01.2006 in higher-grade pay stands null and void.
