**ORDER**

On the basis of selection and consequent upon the acceptance of offer of appointment and acceptance of terms and conditions, the following Senior Research Fellow is appointed in WQM-II Division under PIAS project on River Ganga under Namami Gange Programme in Central Pollution Control Board: -

2. He will be paid monthly stipend of Rs. 28000/- with effect from Date of Joining.
3. He will be entitled for HRA as per DST rules. For this purpose, the stipend admissible to them will be treated as the basic pay.
4. He will not be entitled to DA, Bonus & LTC.
5. He will not be eligible to be a member of the Contributory Provident Fund.
6. The appointment is provisional and will not entitle his to claim absorption in the Central Board in any post/cadre.
7. This appointment is provisional, temporary and all other terms and conditions remains the same as contained in the offer of appointment letter dated 05.07.2018.
8. He is entitled to avail 08 days casual leave in a calendar year. The female candidate JRF is entitled for Maternity Leave as per rules.
9. He will be entitled to TA/DA claims as per Central Pollution Control Board rules.
10. Private work of any kind whatsoever is prohibited during the period of employment in the Central Board.
11. This appointment shall automatically stand cancelled w.e.f. 31.03.2019 (A.N) without any further notice, however the Competent Authority, Central Pollution Control Board may extend as per requirement.
12. The fellowship can be terminated with one month notice in writing on either side without assigning any reasons thereof. Further in case of short notice period a sum of equivalent to salary shall be paid by the concerned JRF or Central Pollution Control Board who gives such short notice.
