MINUTES OF THE MEETING

As per directives of Election Commission of India, the “Voters’ Awareness Forum (VAF)” was constituted in Central Pollution Control Board (CPCB) on 11th March, 2019. The first meeting of the VAF was held on 25th March, 2019 in CPCB under the chair of Sh. R. D. Pandey, Administrative Officer (P). A total of 23 officials/representatives from following Departments/welfare bodies attended the meeting;

1. CPCB Technical & Scientific Officers’ Association,
2. CPCB Officers’ Welfare Association,
3. CPCB Employees’ Welfare Union
4. CPCB Sports Club
5. All Divisional Heads or their Representatives

At the outset Sh. M. K. Choudhury, Scientist-E & Nodal Officer- VAF welcomed all participants and briefed about the purpose of the meeting. The officials were also informed about the initiatives taken by the “Voters’ Awareness Forum” in CPCB to create awareness among the officials and their subordinate staffs so that no voter is left behind in the Electoral process. Accordingly, all officials were requested to check their names in Voters list and help their subordinate staffs for enrolling their name in the electoral roll by visiting the website site www.nvsp.in and voters helpline No. 1950.

Sh. R. D. Pandey, Administrative Officer of CPCB revealed the fundamental right of voting of each citizen including CPCB officials and emphasized on casting vote by all CPCB officials in the electoral processes. The Administrative Officer deliberated upon conducts and procedures of election duties to be performed by CPCB Officials. He also clarified several queries raised by the officials with regard to enrolling in Voters list and procedures for performing election duties. A few officials shared their experience of Election duties among the participants. Further, the respective Divisions and Welfare bodies have agreed to create similar awareness among their subordinate staffs.

The meeting ended by uttering “**Voters’ Pledge**” by all officials.
