2. They will be entitled for HRA and medical benefits as per rules. For this purpose, the stipend admissible to them will be treated as the basic pay.
3. They will not be entitled to DA, Bonus & LTC.
4. They will not be eligible to be a member of the Contributory Provident Fund.
5. The appointment is provisional and will not entitle his/her to claim absorption in the Central Board in a post/cadre.
6. This appointment is provisional, temporary and all other terms and conditions remains the same as contained in the offer of appointment letter dated 19.03.2019.
7. They are entitled to Leave as per rules of CPCB.
8. They will be entitled to TA/DA claims as per Central Pollution Control Board rules.
9. They will report to DH, WQM-II, CPCB Delhi and will perform the duties entrusted to them by the DH, WQM-II.
10. Private work of any kind whatsoever is prohibited during the period of employment in the Central Board.
11. This appointment shall automatically stand cancelled w.e.f. 31.03.2020 (AN) without any further notice, however the Competent Authority, Central Pollution Control Board may extend as per requirement.
12. The fellowship can be terminated with one-month notice in writing on either side without assigning any reasons thereof. Further in case of short notice period a sum of equivalent to salary shall be paid by the concerned RAs or Central Pollution Control Board who gives such short notice.
13. The decision of the Member Secretary, Central Board will be final in all matters relating to their appointment.
14. This issues with the approval of the Competent Authority, Central Board.
