Pursuant to the Ministry of Personnel, Public Grievances & Pensions (Department of Personnel Training) Office Memorandum No. 21011/1/2009-Estt(A)-Part dated 01.02.2012 regarding introduction of Annual Medical Examination for Group 'A' Officers of Central Civil Services of age 40 years and above, the Competent Authority, CPCB has decided that Group 'A' Officers of CPCB of and above the age of 40 years will be covered by the Annual Medical check-up scheme. 
- (i) Annual Medical Examination of Men Officers - Rs. 2,000/- (Rupees Two Thousand Only).


