ORDER

On the basis of selection and consequent upon the acceptance of offer of appointments and acceptance of terms & conditions, the following Junior Research Fellows are appointed at Regional Directorate of CPCB, Lucknow under PIAS project on River Ganga under Namami Gange Programme in Central Pollution Control Board:

2. They will be paid monthly stipend of Rs. 25, 000/- with effect from the date of joining.
3. They will be entitled for HRA as per rules. For this purpose, the stipend admissible to them will be treated as Basic Pay.
4. They will not be entitled to DA, Bonus & LTC.
5. They will not be eligible to be a member of the Contributory Provident Fund Scheme.
6. The appointment is provisional and will not entitle his/her to claim absorption in the Central Pollution Control Board on any post/cadre.
7. This appointment is provisional, temporary and all other terms and conditions remains the same as contained in the offer of appointment letter no. ZOL/Admn/04/JRF/Vol-II/103-104 dated 26.04.2019.
8. They are entitled to avail 08 days casual leave in a calendar year. The lady JRF are entitled for Maternity Leave as per rules.
9. They will be entitled to TA/DA claims as per Central Pollution Control Board rules.
10. They will report to Regional Director, CPCB, Picup Bhawan, Ground Floor, Vibhuti Khand, Gomti Nagar, Lucknow, UP - 226010.
11. Private work of any kind whatsoever is prohibited during the period of employment in the Central Pollution Control Board.
12. This appointment shall automatically stand cancelled w.e.f. 31.03.2020 (AN) without any further notice, however the Competent Authority, Central Pollution Control Board may extend it as per requirement.
13. The fellowship can be terminated with one-month notice in writing on either side without assigning any reasons thereof. Further in case of short notice period a sum of equivalent to salary shall be paid by the concerned JRF or Central Pollution Control Board who gives such short notice.
14. The decision of the Member Secretary, Central Pollution Control Board will be final in all matters relating to their appointment.
