OFFICE MEMORANDUM

Sub. : - Contribution towards Contributory Provident Fund (CPF) from the pay and allowance of Project and Temporary Status Employees for their past service rendered in CPCB – reg.

Refer Office Order No. C-22011/01/2010-Admn.(P)/909 dated the 05th August, 2019 and subsequent OM dated the 29th November, 2019 regarding deduction of CPF from the pay and allowance of the employees engaged on Projects. In this regard the Contribution to be made by each of the employees has been re-calculated as the CPF Contribution has already been deducted w.e.f. June, 2019 in respect of Employees engaged on different Projects and w.e.f. December, 2017 in respect of employees granted Temporary Status. Accordingly, the amount to be contributed by the employees is mentioned at overleaf.

Some of the employees have requested to deposit the arrear of employees share of CPF in installment. The Competent Authority, CPCB has agreed to the requests and the employees have been given option to deposit their share of CPF in maximum of four installments or they may deposit in one lump-sum also. The employer share will also be deposited in the same manner.

02. The interest on the amount deposited in installments and matching contribution will be payable from the date of deposit.

03. Therefore, all Project and Temporary Status Employees are directed to deposit their share of CPF contribution as per their convenient in installments or otherwise as per detail mentioned overleaf at the earliest.
