Dear Sir,

The Competent Authority at Central Pollution Control Board (CPCB) invites Quotations from NABL accredited calibration laboratories, for preparation of Rate Contract panel for Calibration of Laboratory Instruments and equipments during year 2017-2018.

- The Calibration laboratories qualifying the Technical requirements will be shortlisted for Rate Contract for Calibration of Instruments and equipments as and when required.
- The shortlisted and Rate Contracted laboratory may be assigned work for Calibration of Laboratories Instruments and equipments as and when required within a short notice of 7-10 days.
- The laboratory shall make all arrangement for collection of instruments and equipments and their transit for calibration, local transportation for which all-inclusive cost may be quoted in financial part of bid.
- Time period has to be mentioned by respective laboratories in submission of calibration certificate from the date of collection of instruments and equipments.
- Calibration and certification charges of collected instruments and equipments shall be quoted for per Calibration. The validity of quoted prices shall be applicable for one year from the date of opening of quotation.
- The laboratory once contracted has to provide Calibration and certification services for any time till 31st March, 2018 on the contracted rates and terms & conditions.
- The shortlisted and Rate Contract laboratories for Calibration of Instruments and equipments will have to sign agreement with CPCB for undertaking Calibration and certification work and it will not claim any other charges over and above the quoted / accepted rates.
- The Central Pollution Control Board (CPCB) will have discretion to assign the Calibration of Instruments and equipments work to any identified laboratory on the Rate Contract and other laboratories participating in the bid will have no right to compulsorily seek the work from CPCB.
- The Quotation should be submitted in two parts; first part of the Quotation should contain Compliance of Technical Requirement and second part should contain financial.
