03. Terms and conditions:

- i. Bid Security Amount of Rs. 2500/- (Rupees Two Thousand five hundred only) for each vehicle as mentioned above in the form of Demand draft / Pay Order drawn in favour of Central Pollution Control Board, Bengaluru must be enclosed with the Bid/s. Bid Security Amount in any other form i. e cheque or cash will not be considered.
- ii. If it is found that the amount quoted by the successful bidder (i.e. highest bidder) is less than the Reserve Price fixed by the Regional Transport Office (RTO) Bengaluru or the total number of bidders are less than three, the bid shall be treated as cancelled.
- iii. The Bid Security Amount of the successful bidder will be released only after the deposit of sale proceeds. Bid Security Amount will be forfeited if any of the bidder fails to honour the bid.
- iv. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Aadhar Card/Voter Identity Card/Passport/ Driving Licence/ Pan card etc., in case of individual and Registration Certificate in case of firms etc.
- v. The successful bidder have to shift the vehicle/s at his own cost within three days of final payment, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulter.
- vi. The vehicle will be disposed off "As is where is basis"
- vii. The successful bidder will also be responsible for getting the Registration Certificate, Insurance and other documents of the vehicle transferred in his name at his/their own cost expeditiously. The CPCB will not be responsible for any lapse on his part in this regard.
- viii. The bidder has to provide the copy of Photo identity card/Pan card/Aadhar card while submitting the quotation without which the quotation will be accepted and becomes invalid.
- xi. The bidders will not be allowed to withdraw their bids, failing which their Bid Security Amount will be forfeited.
- x. In case of the non-availability of Original Certificate of Registration (RC book) in the office, attested photocopies of the same along with copy of FIR shall be provided.
- xi. The Chairman, CPCB reserves the right to accept or reject any/ all of the quotation without assigning any reason thereof.
- xii. All taxes/levies/Insurance/Registration cost etc. will be borne by the buyer over and above the bid price & CPCB will not bear any of the expenses in this regard.
