The EMD of unsuccessful bidders shall be returned after award of work to successful bidder. The EMD of successful bidder shall be deposited in CPCB account and will be refunded after satisfactory completion of work. No interest shall be paid on it.
3. The rates quoted should be as per our specification.
4. The firm should have completed atleast 02 similar work satisfactory during the last 02 years in Govt./Semi Govt./Govt. Undertaking/reputed firms and have to provide documentary evidence for the same.
5. Payment will be made after satisfactory completion of work and submission of proper bill/invoices(indicating clear taxes). No advance payment will be made.
