03. Terms and conditions:

- i. Bid security amount of Rs. 15,000/- (Rupees Fifteen Thousand only) for the office vehicle as mentioned above in the form of Demand draft / Pay Order drawn in favour of Central Pollution Control Board, Bengaluru shall be enclosed with the Bid. Bid security amount in any other form i. e cheque or cash will not be considered.
- ii. The amount quoted by successful bidder (i.e. highest bidder) is less than the Reserve Price fixed by the Regional Transport Office (RTO) Bengaluru or the total number of bidders are less than three, the bid shall be treated as cancelled.
- iii. The bid security amount of the successful bidder shall be released only after the deposit of sale proceeds. Bid security amount will be forfeited if any of the bidder fails to honour the bid.
- iv. The delivery of the sold vehicle shall be arranged after the successful bidder submits documentary evidence in support of residential status viz. Aadhar Card/Voter Identity Card/Passport/ Driving Licence/ Pan card etc., in case of individual and Registration Certificate in case of firms etc.
- v. The successful bidder have to shift the vehicle at his own cost within one week of final payment, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulter.

- xi. The bidders shall not be allowed to withdraw their bids, failing which their Bid Security Amount shall be forfeited.
