Sub: Inviting sealed quotation for Participating in PT programme

Central Pollution Control Board is a statutory body under the Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi. CPCB, Regional laboratory located at Bengaluru is accredited by NABL-QCI, as per ISO/IEC 17025:2005. The Regional laboratory would like to participate in Proficiency Testing (PT) programme, through PT providers accredited by NABL-QCI or any other Global agency accredited in compliance with ISO/IEC 17043:2010. The parameters for which the laboratory requires for PT are given in annexure.

Sealed quotations are invited in single stage two bid system (Technical and financial bid) from reputed agencies providing PT programme. Technical bid cover shall contain copy of valid certificate issued by NABL-QCI or any Global agency accredited as per ISO/IEC 17043:2010 along with scope of accreditation. Financial bid cover shall contain details of scheme code, description of sample, parameters covered, rate for the scheme, month of PT programme, last date for registration and date of report release. Other details, such as GST %, Packing & Forwarding charges, if any, shall be mentioned clearly.

Quotations shall be submitted to this office **on or before Friday, 3rd July, 2020 at 17.00 hours**. The other terms and conditions are given below:

Terms and Conditions:

1. The tender shall be submitted in two parts, viz. Technical bid and Financial bid. The bids shall be kept in two separate sealed cover mentioning technical bid and financial bid and both the covers shall be kept in a single cover and sent to this office superscripted with **"Quotation for PT Programme" on top left side of the envelope.**
2. Financial bid shall be opened only after qualification in technical bid.
3. PT provider shall have valid certificate issued by NABL-QCI or any Global agency accredited in compliance with ISO/IEC 17043: 2010 up to 31st March 2021.
4. PT provider shall ensure that minimum 8-10 participants participate in each programme
5. The validity of quotation shall be for 90 days from the date of opening
6. **DSIR certificate and essentiality certificate will be submitted along with supply order for GST concession.**
7. All charges including scheme rate, GST, transportation etc. shall be mentioned clearly.
