Terms & Conditions:

1. Sealed quotations should be dropped in the quotation box kept at reception (Ground Floor) of Parivesh Bhawan, CPCB on or before 02.08.2021 by 3.00 pm. The same will be opened on 02.08.2021 at 03:30 P.M.
2. The bidder has to submit the duly signed “Bid Security Declaration” (EMD) accepting that if they withdraw or modify their bids during period of validity, they will be suspended for a period of 06 months for all tenders of CPCB published during this period.
3. The terms & conditions and taxes etc. should be clearly mentioned in the quotation.
4. The quotations shall be valid for 03 months from the date of its opening.
5. The rates quoted should be as per our specification.

6. Payment will be made after satisfactory supply, fixing and testing of valves in the existing gas pipe line system. No advance payment will be made.
7. The material should be got approved from CPCB before start of installation.
8. The bidder has to submit the following documents in the technical bid:-
 - a) Copy of valid PAN card, and copy of GST registration no.
 - b) Copy of registration in Govt. organisation.
 - c) Should have completed atleast one similar nature of supply & fixing work in any Govt. organisation/reputed firm during last 03 years.
 - d) 'Bid Security Declaration (EMD) exemption undertaking on firm letter head.
9. The financial bid will be opened for only those firms, who will found technically qualified.
10. The successful bidder has to submit performance guarantee equal to the 03% of the awarded value within 10 day from the date of award of work valid for a period of 07 months.
11. The work should be completed within 01 months from the date of issue of work order.
12. Income Tax shall be deducted at source.
13. It may be noted that mere quoting the lowest rates will not entitle any firm to get the work order.
14. The over writing and corrections, if any should be counter signed.
15. The Chairman, Central Pollution Control Board reserves the right to cancel any or all the quotations without assigning any reasons thereof.
16. In the event of any dispute, the decision of the Chairman, Central Board shall be final and binding on both the parties.
