6. **Test certificate along with validity date of masters used shall be submitted while submitting the test certificate.**
7. Duly filled in quotation shall reach this office on or before **11<sup>th</sup> August, 2021 at 16.00 hours.**
8. The quotations may be sent by registered post or may also be dropped in the tender box kept at this office.
9. Payment will be made through PFMS after satisfactory completion of work and submission of test certificate and bill in duplicate.
