1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned

Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Terms and Conditions

1. The bidder/supplier should be Delhi-NCR based.
2. The specification of analytical gases have been indicated in the specification document and the gases of mentioned purity specification shall only be supplied alongwith the Certificate of purity to CPCB Laboratories. Purity certificate will be provided by the supplier alongwith the delivery of the gases.
3. The offered rate per cylinder as above shall be on Free Delivery at Site (respective laboratory of CPCB, Delhi) basis including loading/unloading and taxes. No additional transportation, freight, handling charges shall be applicable over and above the mentioned rates.
4. The requirement of analytical gases for refilling will be informed periodically by CPCB Laboratories through Email/Phone/Mobile in to the supplier. The empty gas cylinders will be provide by CPCB Laboratories, which are to be refilling and returned preferable within 48 hours but not more than five days (one week) of

receipt of empty as cylinder/s.

5. The suppliers has to make arrangement immediately, preferably on the same day for collection of empty gas cylinder from CPCB Laboratories located at Ground/2nd/3rd /4th floor, Parivesh Bhawan, East Arjun Nagar, Delhi and return these duly filled up with required purity of specified analytical gases. The entire responsibility during transit shall be yours.

6. The supplier has to reimburse the entire cost of cylinder in case it is lost by the supplier or returned to the laboratory in damaged condition. The responsibility for repair of the damages caused to the empty gas cylinder provided by CPCB during refilling of Gas cylinder shall lie with the contractor and the entire cost of replacement of gas cylinders or for the repair has to be borne by the contractor.

7. The supplier has to undertake External/Internal Cleaning of gas cylinders proper flushing of gas cylinder, degreasing, testing and other required services before filling up the analytical gases. Valve check, leak check in the cylinder after refilling. The refilled as cylinder should be supplied duly sealed to CPCB laboratories.

8. The quantity of analytical gases in the gas cylinder shall be measured in presence of supplier representative through pressure gauge at the time of receipt of refilled gas cylinder at the laboratories. The supplier will maintain the record of the Cylinder Pressure against each cylinder in the Challan Receipt during the delivery period. Any refilled gas cylinder found having inadequate pressure or of inferior quality the supplier has to refill these gas cylinders once again.

9. All gas cylinders are required to be assessed, tested periodically as per the Gas Cylinder Rules, 2016. Responsibilities for compliance with this govt. Rules rests with the supplier, who will periodically carry out tests as may be required under the Rules before refilling the cylinder for which no additional charges shall be payable.

10. The supplier has to ensure adequate safety provision, while handling pressurized gas cylinders and their transportation, CPCB shall not be responsible for and mishap/accident caused due to mishandling of pressurized cylinder at suppliers end or during transit.

11. The suppliers has to bring delivery Challan in duplicate at the time of delivery of duly filled up gas cylinders to the laboratory. One copy of delivery Challan will be provided to concerned laboratory alongwith the refilled gas cylinder, while other copy may be got signed from CPCB Laboratory representative as a receipt of supply of gas cylinder.

12. The signed delivery Challan by CPCB Laboratory representative should be submitted to Material Section, Central Pollution Control Board alongwith Invoices/Bills in duplicate none in three months (quarterly) for processing the payment.

13. On supply of gases in required purity alongwith Certificate of Purity and required quantities the CPCB laboratory will make endorsement on the bill/invoice for receipt of analytical gases in satisfactory condition. The payment will be processed thereafter.

14. The payment will be released on quarterly basis after submission and verification of bills. If the material is found defective or sub-standard or not up to the satisfaction of the Competent Authority, the same will be replaced by you and on charge on this account will be paid to you.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
