Terms & Conditions:

1. Sealed quotations should be dropped in the quotation box kept at reception (Ground Floor) of Parivesh Bhawan, CPCB on or before 22.02.2011 by 3.00 pm. The same will be opened on same day at 3.30 p.m.
2. The quotation has to be accompanied by an EMD of Rs. 6200/- (Rs. Six Thousand Two Hundred only) as Demand Draft in favour of Central Pollution Control Board, Delhi. The EMD of unsuccessful bidders shall be returned after award of work to successful bidder. The EMD of successful bidder shall be deposited in CPCB account and will be refunded after satisfactory completion of work. No interest shall be paid on it.
3. The rates quoted should be as per our specification. The bidders are requested to visit the site before submission of their offers.
4. Payment will be made after satisfactory completion of work and testing of complete system. No advance payment will be made.
5. 10% security will be deducted/retained from the bill for defect liability period of 06 months.
6. The defect if any, found within 06 months after completion of the work should be rectified by the quotee at his own cost.
7. The work should be completed within 03 month from the date of issue of work order.
8. Income Tax shall be deducted at source.
9. The work shall be carried out strictly according to CPWD specifications for civil work.
10. It may be noted that mere quoting the lowest rates will not entitle any firm to get the work order.
11. The Chairman, Central Pollution Control Board reserves the right to cancel any or all the quotations without assigning any reasons thereof.
12. The quotations shall be valid for 03 months from the date of their opening.
13. The terms & conditions and taxes etc. should be clearly mentioned in the quotation.
14. The over writing and corrections, if any should be counter signed.
15. In the event of any dispute, the decision of the Chairman, Central Board shall be final and binding on both the parties.
