6. Printer shall abide by the colour scheme suggested by the Central Board.
7. For any sundry items (i.e. items other than above) the rates actually prevailing in the market at the given time shall be obtained.
8. Bill in duplicate shall be submitted by the party within 7 days after compliance of the complete work order, failing which no claims shall be entertained.
9. Sales Tax etc. shall be payable by the Board, as per rule.
10. TDS shall be deducted at source from the bill, at the time of payment source, as per rule.
