

Terms and Conditions:

1. Sealed quotations should be dropped in the quotation/tender box kept on ground floor (near reception) of Central Pollution Control Board on or before 27.10.2015 by 3:00pm. and the same will be opened by 3:30p.m. on the same day.
2. The firm has to produce the documentary evidence for completing at least two similar works of not less than Rs. 3.0Lacs each, during last two years.
3. The firm should have authorized servicing centre in Delhi/ NCR.
4. The firm should be an authorized dealer/ distributor/ channel partner of M/s Edward Fire Alarm Systems and should also produce documentary evidence from the principle firm i.e. M/s Edward Fire System for providing the full technical support for executing this work in CPCB.
5. The firm should provide the Warranty/ Guarantee for the replaced parts of the system at least for a period of one year from the date of handing over the system to CPCB.
6. The quotation should be to submitted alongwith an EMD of Rs.8,000/- (Rupees Eight Thousand only) in favour of Central Pollution Control Board, Delhi. The EMD of unsuccessful bidders shall be returned after award of work to the successful bidder. The EMD of successful bidder shall be deposited in CPCB A/c and will be released after completion & handing over of the work in satisfactory condition to CPCB. No interest shall be paid on it.
7. The rates quoted should be as per our specifications. The firm has to provide certificates wherever applicable.
8. 10% of awarded value will be retained as a security deposit for the defect liability period of one year and shall be released at the end of warranty/guarantee period, without any interest. If the firm submits bank guarantee of equivalent amount i.e. 10% of the awarded value with the validity period of one year, the balance 10% amount will be released.
9. Terms of Payments
 - 9.1 60% of the total cost of the work, on receipt of materials in good condition at site after inspection by the CPCB's Officers.
 - 9.2 30% of the total cost of the work on Erection, Commissioning and Testing and acceptance thereof by the CPCB.
 - 9.3 Balance 10% of the total cost of the work will be paid at the end of the warranty/ guarantee period of one year and will be treated as a security deposit. However, if the bidder furnishes Bank Guarantee of the equivalent amount and valid till expiry of warranty/ guarantee period i.e. one year, the balance 10% shall be released alongwith 30% payment as above.

10. Defect if any, found within 12 months after completion of work shall be rectified by the firm at free of cost.
11. The terms & conditions such as guarantee/warranty period, taxes etc. should be clearly mentioned in the quotation.
12. The work should be completed within 02months from the date of issue of work order.
13. The work should be carried out strictly according to CPWD/NBC specifications.
14. It may be noted that mere quoting lowest rates will not entitle any firm to get the work order.
15. The quotation should be free from over writing and corrections and additions if any, should be counter signed.
16. The Chairman, CPCB reserves the right to cancel any or all the quotations without assigning any reason thereof.
17. In the event of any dispute, the decision of Chairman, CPCB shall be final and binding on both the parties.
18. Typographical and clerical errors are subject to correction.
