Sub: Modified Directions under Section 18 (1) (b) of the Water (Prevention and Control of Pollution) Act, 1974, regarding monitoring of Common Effluent Treatment Plants (CETPs)

- Ref.: 1. Ministry of Environment, Forest & Climate Change Notification No. S.O. 4(E) of 01.01.2016, regarding effluent quality standards of CETPs.**
- 2. CPCB's Modified Directions under Section 18(1)(b) of the Water (Prevention and Control of Pollution) Act, 1974, vide letters no. PCI-SSI/CETPs Monitoring Direction/2016, dated 31.03.2016, regarding monitoring of CETPs.**
- 3. CPCB's earlier request vide letter no. PCI-SSI/ CETPs Monitoring Direction/2016, dated June 10, 2016, regarding regular monitoring of CETPs.**

Sir,

Please refer to the above notification of MoEF&CC and modified directions of CPCB on the above subject regarding regular monitoring of CETPs and taking follow-up action, which also required prescribing inlet quality standards by your board for each CETP in your state for general parameters, ammonical nitrogen and heavy metals as per design of the CETP and uploading performance status in respect of each monitoring on SPCBs website from April 2016 onwards.

It has been observed that system of quarterly or monthly monitoring of CETPs have been developed by SPCBs, but effective follow-up action to achieve compliance of standards by non-complying CETPs is lacking and quarterly ATRs on above directions are not being forwarded regularly by several SPCBs.

It has also been observed that many SPCBs/PCCs have not yet prescribed inlet quality standards for CETPs in their state as per above referred notification of MoEF&CC, dated 1/1/2016.

It is, therefore, requested to provide the compliance status for the following:

B/C

1. To prescribe the inlet quality standards for compliance by member units of all the CETPs in your state as per the MoEF&CC Notification dated 1st January 2016 and upload the prescribed inlet quality standards on SPCB/PCCs website under intimation to CPCB.
2. To update and upload the status of Online Continuous Effluent Monitoring System (OCEMS) connected with CETPs on SPCBs/PCCs website regularly under intimation to CPCB.
3. To provide the performance status of all CETPs in respect of each monitoring and upload the same on SPCBs/PCCs website regularly.
4. To take suitable action against industries / CETPs not complying with the prescribed standards.
5. To take suitable action to stop bypass of untreated industrial effluents from industries / industrial estates, wherever applicable.
6. To upload the performance and operational status of existing Primary Effluent Treatment Plants (PETPs) of member units connected with CETPs in compliance to the prescribed inlet quality standards.

It is requested that compliance report on the above mentioned directions shall be provided to CPCB at the earliest, preferably by e-mail (aks.cpcb@nic.in) or fax (22302188) within 15 days.
