Bihar

Out of 744, there are 64 HCFs have applied for Consent under Water Act, 1974 and the Air Act, 1981.

Chandigarh

Incinerator of PGI is being unsed by CBWTF operator and incinerator of Govt. Multi Speciality Hospital Sec 16 is being used by all Govt. Dispensaries. GMCH 32 is using the incinerator facility of PGI & GMSH 16. Amritsar Health Care System transported Bio-medical waste of 43 nos. of Govt. Dispensaries to GMCH Sec 16 Chandigarh for treatment. Punjab university transported their waste to PGIMER for treatment in their own vehicle.

Delhi

- * The figure includes health care units which have patients strength even less than 1000 and drug mfg./stocklist units.

270 HCFs had not applied for renewal of authorization under BMW Rules, letters/Show Cause Notices issued & thereafter HCFs have either applied or informed regarding closure of the unit etc.

Goa

The HCFs mostly dispose their waste after treatment as prescribed in the BMW Rules to Municipal sites but the same do not have any landfill site for disposal of the liquid waste generated from the HCFs in the state of Goa have little quantity of liquid waste generated hence they dispose it into PWD sewage system or into own septic tank and soak pit after pretreatment as prescribed. The major hospitals in Goa Goa medical does not submit Annual Report & show-cause notice is being issued to the same for non-compliance. The matter is presently sub-judice in Suo Moto WP 2 OF 2007 befire the Hon'ble High Court of Bombay, Punaji.

Kerala

All the HCUs are having some system for the treatment and disposal of bio-medical waste. But some of these are not fully in accordance with the methods stipulated in the Rules. Some of the HCFs have joined the common facility maintained by the IMA at Palakkad (IMAGE). Govt. have signed MoU with IMAGE to utilize their treatment & disposal facilities for the Govt. HCEs in the state and there is good progress in affiliating Private as well as Govt. institutions with common facility at IMAGE. Hence individual institutions are being pressurized to set up individual facilities.

Lakshadweep

* Lakshadweep PCC informed telephonically that the incinerator installed at HCF is with APCD.

Maharashtra

* CBWTF namely Krupa Wastages, Amogaon, Distt. Gondia is given consent to establish, BMW generated in the Gondia & Bhandara Distt. Is treated by CBWTF operated by M/s Superb Hygenic Disposal, Nagpur.

Mizoram

Most of the HCFs are having 'Deep Burial' facility.

Nagaland

NPCB forwarded two proposals to MoEF for setting up of CBWTF at Kohima and Dimapur on 90:10 basis, which was submitted by the Municipal Council. However, the Ministry had not considered the proposals.

Orissa

* Treatment facilities (Incinerator, microwave & shredder) of MKCG Medical College & Hospital is being shared by the HCUs of Behrampur for treatment of bio-medical wastes.

Puducherry

* Consent to operate has been issued to CBWTF namely M/s Pondicherry Solid Waste Management Company Pvt. Ltd., Thuthipet, Villianpur Commune, Puducherry recently. The CBWTF with incinerator of capacity of 100 Kg/hr & other treatment facilities is yet to commence its operation & fix the cost of treatment of BMW.

Puniab

* PPCB has issued NOC to the 5th CBWTF to be installed at Distt. Bathinda.

Rajasthan

* RSPCB is pursuing the Director, Local Bodies for expediting the commissioning of the proposed three CBWTFs at Jalore, Udaipur, Sikar & also advising for additional CBWTF for connectivity of all HCFs to CBWTF.

Tripura

The quantity of bio-medical waste generated per day by State Hospital, Medical College & Sub divisional hospitals has only been assessed.

Health Department is trying to set up BMW Treatment & Disposal in all the District Hospitals/Sub-Divisional Hospitals/Rural Hospitals and Deep Burial Pit has already been constructed in all the PHCs in Tripura

AMC has installed an incinerator & has started collecting BMW from many HCEs in and around Agartala and disposing BMW.
