- The registered PRO shall maintain information related to its toll free numbers, customer care numbers, list of dismantlers, list of recyclers, list of its collection centres, list of collection points and details of its reverse logistic partners (transporters) along with their contact details on its web sites [www.earthsenserecycle.com](http://www.earthsenserecycle.com).
- The registered PRO shall maintain records of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when required.
- The registered PRO shall file annual returns to the Central Pollution Control Board on or before 30th day of June following every financial year.
- The registered PRO shall comply with provisions of the Environment (Protection) Act, 1986, E-Waste (Management) Rules, 2016, E-Waste (Management) Amendment Rules, 2018, other applicable regulations and CPCB's guidelines issued from time to time under these rules.
- An application for the renewal of registration shall be made before 60 days of its expiry.
- The Central Pollution Control Board reserves right to cancel/amend/revoke the PRO registration at any time in case of any violation of the E-Waste (Management) Rules 2016 and amendments thereafter or CPCB's guidelines issued from time to time under these rules.
