Sub: Directions under Section 5 of the EPA, 1986, regarding compliance of various provisions under Schedule – II of Plastic Waste Management Rules, 2016, i.e., Guidelines on Extended Producer Responsibility (EPR)

WHEREAS, the Ministry of Environment, Forest & Climate Change (MoEF&CC) has notified Plastic Waste Management Rules, 2016, in exercise of the powers conferred under sections 3, 6 & 25 of the Environment (Protection) Act, 1986 vide Notification No. G.S.R 320 (E) dated March 18, 2016; and

**WHEREAS**, Plastic Waste Management Rules, 2016 was amended and notified by Ministry of Environment, Forest & Climate Change (MoEF&CC) on 16 February, 2022 to insert Schedule – II, *i.e.*, Guidelines on Extended Producer Responsibility for Plastic Packaging (hereinafter referred as "EPR Guidelines"); and

WHEREAS, as per Section 6.1(a) of the EPR Guidelines, "The following entities shall register on the centralized portal developed by Central Pollution Control Board namely: - (i) Producer (P); (ii) Importer (I); (iii) Brand owner (BO), (iv) Plastic Waste Processor engaged in (a) recycling, (b) waste to energy, (c) waste to oil, and (iv) industrial composting"; and

WHEREAS, as per Section 11.1 of the EPR Guidelines, "All plastic waste processors shall have to register with concerned State Pollution Control Board or Pollution Control Committee in accordance with provisions of 13(3) of Plastic Waste Management Rules, 2016 on the centralized portal developed by Central Pollution Control Board. Central Pollution Control Board shall lay down uniform procedure for registration within three months of the publication of these guidelines"; and

**WHEREAS**, CPCB developed the Standard Operating Procedure (SOP) for registration of PWPs on March 15, 2023 and uploaded the same on CPCB website in accordance with EPR guidelines; and

WHEREAS, as per Section 11.2 of EPR Guidelines, "The Plastic waste processors shall submit annual returns after end of every financial year by 30th April of the next financial year on the quantity of plastic waste processed category-wise as per prescribed pro forma on the centralized portal developed by Central Pollution Control Board"; and

WHEREAS, as per Section 11.5 of the EPR Guidelines, "Only plastic waste processors registered under Plastic Waste Management Rules, 2016, as amended, shall provide certificates for plastic waste processing, except in case of use of plastic waste in road

construction. In case where plastic waste is used in road construction the Producers, Importers & Brand-Owners shall provide a self-declaration certificate in pro forma developed by Central Pollution Control Board. The certificate provided by only registered plastic waste processors shall be considered for fulfilment of Extended Producer Responsibility obligations by Producers, Importers & Brand-Owners", and

WHEREAS, as per Section 11.7 of the EPR Guidelines, "The certificate for plastic packaging waste provided by registered plastic waste processors shall be in the name of registered Producers, Importers & Brand-Owners or Local authorities, as applicable, based upon agreed modalities. Central Pollution Control Board will develop mechanism for issuance of such certificate on the centralized portal "; and

WHEREAS, as per the EPR Guidelines, CPCB has developed the Centralized portal for registration of Producers, Importers and Brand-owners (PIBOs) & Plastic Waste Processors (PWPs) that has been formally launched on April 05, 2022; and

WHEREAS, CPCB has developed the mechanism for Generation & Transfer of EPR Certificates (as given in the Guidance Manual developed by CPCB) by PWPs on the EPR Portal and the corresponding online module of the EPR Portal was launched on November 19, 2022; and

WHEREAS, Registration of PWPs by SPCBs/PCCs is on the basis of information provided online by PWPs on the EPR Portal which includes details of plant and machinery (processing capacity, production capacity, power rating, etc.), geotagged photograph of the plant & machinery, raw material, production and sales section of the Units, short video of the Unit etc.; and

WHEREAS, as per clause 4(iv) of SOP "Physical Audit of the PWP to be completed by SPCB/PCC within 30 days of grant of Registration. The PWP shall be able to issue certificates to PIBOs post conduction of Audit and validation of its facilities by the SPCB/PCC"; and

WHEREAS, in accordance with aforesaid clause of SOP, upon grant of registration to PWP, SPCB/PCC are required to physically verify details of plant and machinery (processing capacity, production capacity, power rating etc.), geotagged photograph of the plant & machinery, raw material, production and sales section of the Units, short video of the Unit etc. as per the checklist provided on EPR portal for the purpose; and

WHEREAS, CPCB has developed the Guidance manual for operating Centralized EPR Portal which includes details of procedure for Registration of PIBOs/PWPs, Generation & Transfer of EPR certificates etc., which was made available on EPR portal. Several training sessions/meetings were also conducted with SPCBs/PCCs/Industrial Associations/PWPs and other stakeholders in which inspection requirements/procedures for grant of approval of physical verification of PWPs to be followed by SPCBs/PCCs were covered. SPCBs/PCCs were required to upload approval status of Physical verification of PWPs on the EPR portal following these procedures; and

WHEREAS, CPCB vide directions dated 10.03.2023 and 04.07.2023 reiterated that all SPCBs/PCCs to complete physical verification of all registered PWPs in their jurisdiction within the stipulated time frame to enable the PWPs to generate EPR certificates within the timelines stipulated in EPR guidelines; and

WHEREAS, CPCB vide directions dated 21.12.2022 had directed all PWPs to upload GST E-invoice of all transactions (sales/ purchase) related to processing of plastic packaging & plastic waste on the EPR Portal; and

WHEREAS, viewing rights of the PWP dashboard have been provided to the officials of SPCBs/PCCs to monitor the PWP operations including procurement, production, sale and Certificate generation & transfer by PWP Units registered in their jurisdiction and the same was communicated during the training sessions for SPCBs/PCCs conducted by CPCB for the purpose; and

WHEREAS, Section 12.4 of the EPR Guidelines provides that "Central Pollution Control Board by itself or through a designated agency shall verify compliance of Producers, Importers & Brand-Owners through inspection and periodic audit, as deemed appropriate. Central Pollution Control Board, as required, can also verify compliance of Plastic Waste Processors through inspection and periodic audit. In case of plastic waste processors and Producers, Importers & Brand-Owners operating in a State or Union Territory, Central Pollution Control Board may, if required, direct State Pollution Control Board or Pollution Control Committee to take action"; and

WHEREAS, random sample audit of M/s Enviro Recyclean Pvt Ltd., Ram Nagar, Karnataka (plastic waste recycler) was conducted by CPCB on August 30, 2023 in accordance with Clause 12.4 of the EPR Guidelines; and

WHEREAS, M/s Enviro Recyclean Pvt Ltd, was registered with Karnataka State Pollution Control Board (KSPCB) on 25.04.2023 followed by physical verification of the Unit and uploading approval thereto by KSPCB on 29.03.2023 on the EPR portal; and

WHEREAS, the following observations were made by the CPCB officials during the aforesaid audit:

- a. The plastic waste processing capacity of the Unit is 350000 Tonnes per Annum (TPA), as registered by Karnataka State Pollution Control Board (KSPCB) and Consent to Establish and Consent to Operate had been issued to the Unit. As per the Audit team observations, one double shredder machine (manual feeding to shredder), four washers (two washers in series), two driers, one agglomerator and one extruder machine were installed in the plant but the same were not in operation as Electricity and water connection had not been provided to the plant machinery; electrical and civil works were in progress during the Audit .The Unit could not perform/demonstrate trial run to assess the processing capacity, as per the CPCB Audit team directions. Further, the machinery placed in the plant is not in conformity with the plant machinery declared in the application form. The plant machinery corresponding to the registered capacity of 350000 TPA was not found to be installed/commissioned in the Unit by the Audit team.
- b. The Unit has generated EPR Certificates of the order of 350000 Tonnes and transferred EPR Certificates of 348500 Tonnes value to Producers/Importers/Brand Owners (PIBOs). Quantities mentioned in the invoices uploaded on EPR Portal by the Unit are fallacious & very high as compared to the declared production capacity since the plant operations had not yet commenced. As per the information on the EPR Portal, all invoices have been generated for Services provided towards collection and recycling and not for the requisite actual sales of recycled plastic.

- c. No relevant information as stated below were made available to verify processing of 350000 tonnes of plastic waste and sale of corresponding quantity of finished product, by the Unit to the audit team:
  - i. Procurement of Plastic waste (Procurement invoices, Supplier details, etc.)
  - ii. Procurement of additives required for processing plastic waste
  - iii. Sale of recycled plastic (GST Statement, Sales invoices, etc.)
- d. The geotagged photographs /video of the plant uploaded with the application are not in conformity with the actual observations during the Audit, indicating that fabricated photographs had been uploaded with the application. It is observed that the same was also not checked & verified during the Physical verification by SPCB.
- e. The Consent to Establish (27.2.23) and Consent to Operate (7.3.23) have been granted in quick succession within a gap of seven days. It is not clear as to how the Unit, which is a large-scale Unit, was established within seven days' time. It was also observed that rental agreement of the Unit was signed only on 01.2.2023.
- f. ETP of the plant was found to be under construction during the Audit, despite the fact that CTO has been granted to the Unit by KSPCB.
- g. Only four workers were available in the Unit as against 74 reported in the application form

In view of the above, it is observed that EPR Certificates of the value of 3,50,000 Tonnes have been generated by the Unit whereas the Unit neither has processing capacity for the said quantity nor relevant prescribed supporting documents/information for the same. The Unit has obtained registration and generated the said EPR certificates of 3,50,000 Tonnes without any actual processing of plastic waste at the Unit and by submitting false documents/information, which is in gross violation of provisions of EPR Guidelines as notified under Schedule II of the PWM Rules by MoEFCC, CPCB's Guidance manual for operating Centralized EPR Portal and other directions/communications issued by CPCB from time to time in this regard. The process of generation of EPR Certificates by the Unit was also not monitored by KSPCB, despite being the enforcing agency notified under the PWM Rules and having provision of viewing the PWP dashboard on the EPR portal; and

WHEREAS, as per Section 11.4 of the EPR Guidelines "In case, at any stage it is found that the information provided by the plastic waste processor is false, the plastic waste processor shall be debarred by State Pollution Control Board, as per procedure laid down by Central Pollution Control Board, from operating under the Extended Producer Responsibility framework for a period of one year"; and

**WHEREAS**, as per Section 11.6 of the EPR Guidelines "The pro forma for the certificate shall be developed by Central Pollution Control Board. In no case, the amount of plastic packaging waste recycled by the enterprise shall be more than installed capacity of the enterprise. The certificates will be for plastic packaging category-wise and shall include GST data of the enterprise"; and

WHEREAS, as per Section 13.1 of the EPR Guidelines "The concerned State Pollution Control Board or Pollution Control Committee shall register Producers, Importers & Brand-Owners (operating in one or two states) and plastic waste processors, through the online portal developed by Central Pollution Control Board. Provision for registration shall be made on the Extended Producer Responsibility portal. State Pollution Control Board or Pollution Control Committee by itself or through a designated agency shall verify compliance of Producers, Importers & Brand-Owners through inspection and periodic

audit, as deemed appropriate, of Producers, Importers & Brand-Owners as well as plastic waste processors in their jurisdiction as per the Plastic Waste Management Rule, 2016"; and

**WHEREAS,** as per Rule 18 of PWM Rules " *The Environmental Compensation shall be levied based upon polluter pays principle, on persons who are not complying with the provisions of these rules, as per guidelines notified by the Central Pollution Control Board"; and* 

WHEREAS, as per the EC Regime framed by CPCB in 2022, Environmental Compensation is to be levied on PWP @ Rs. 5000/- per ton of plastic waste misreported for quantity of plastic procured and EPR certificate generated after following due legal procedure"; and

**NOW, THEREFORE**, in view of above and in exercise of the powers vested to Chairman, Central Pollution Control Board (CPCB) vide Notification No. S.O.730 (E) dated July 10, 2002 notified as per provisions of Section 5 of the Environment (Protection) Act, 1986, following directions are issued for compliance:

- To conduct detailed enquiry into the issue of CTE and CTO and also as to how physical verification of the Unit M/s Enviro Recyclean Pvt Ltd was approved by KSPCB on the EPR portal, in view of the gross violations observed by the Audit team, as above, and also as to why the process of generation of EPR Certificates was not monitored by KSPCB.
- 2. To fix the liability on erring official/s and take disciplinary action against erring officials, if any, as per the findings of the enquiry set up, as at (1) above.
- To immediately take the following actions against the afore-mentioned PWP Unit namely M/s Enviro Recyclean Pvt Ltd (Reg. No.: PR-25-KAR-04-AAFCE9612E-23):
  - To suspend the consent/authorization/registration issued to the Unit with immediate effect and issue show cause notice for debarring the Unit from operating under the Extended Producer Responsibility framework for a period of one year as per Clause 11.4 of the EPR Guidelines or/ and for revocation of the consent/authorization/registration issued to the Unit;
  - ii. To levy Environmental Compensation (EC), corresponding to the quantum of EPR certificates generated not in conformity with requirement prescribed in CPCB Guidance manual for operating Centralized EPR Portal. The EC is to be levied as per "Guidelines for Assessment of Environmental Compensation to be levied for violation of PWP Rules" (https://cpcb.nic.in/uploads/plasticwaste/EC\_Regime\_PWM.pdf) and Unit be directed to deposit the same in the designated Escrow Account, created by the KSPCB for the purpose.
  - iii. To take necessary action against every Unit as per applicable law as the Units have submitted false documents for obtaining registration as well as for generating EPR certificates. It may further be ensured that action taken by KSPCB regarding these units should act as a deterrent for other Units in committing such violations.

4. To take immediate necessary actions to improve upon the system of grant of registration within KSPCB, monitoring and enforcement thereto ensuring compliance of the Plastic Waste Management Rules, EPR guidelines and directions/guidelines issued by CPCB, including the following:

Inspection of all processing facilities of Registered PWPs in your jurisdiction within a fortnight from the issue of these Directions and to confirm that the Processing capacity as per the Registration granted to units is in conformity with the actual facilities provided in each Unit. All other information provided in the online application form are also to be revalidated by KSPCB.

- Regular monitoring of EPR Certificate generation process of the Registered PWPs to ensure that EPR Certificates generated by PWPs are in accordance with requirements prescribed in the CPCB guidance manual including uploading of GST E-invoice corresponding to the sales of finished products on the EPR Portal.
- 5. To take all necessary steps to ensure that every Unit henceforth complies with all conditions including generating GST E-invoice for all sales of finished products and uploads the same on the EPR Portal, failing which necessary action be immediately taken including levying of EC against each non-complying Unit.

You are, hereby, directed to take necessary action immediately for ensuring compliance of the aforesaid directions and submit action taken report to this office within 10 days from the date of issuance of this direction.

- 1. Issued directions to Regional SEO-Ramanagara and RO- Ramanagara vide ref (2) to take immediate action for withdrawal of said CFO issued to the industry. (Copy of the same is enclosed as Annexure-I).
- 2. RSEO, Ramanagara has withdrawn the Consent for Operation issued under Water and Air Act vide No. KSPCB/RSEO-RAMANAGARA/ENVIRO/2023-24/92, Dated: 03.11.2023 vide ref (3) (Copy of the same is enclosed as Annexure-II).
- 3. The Board has conducted Personal hearing (PH) on 21.11.2023 as per the Rule 13(10) of PWM Rules,2016 vide ref (5) and the proceedings of the hearing is issued vide letter No. PCB/WMC-1/78/PLS/2023-24/4644 dt. 28.11.2023 vide ref (6). (Copy of the PH proceeding is enclosed as Annexure-III). As per the proceeding of the PH, the Board has revoked EPR registration issued under Plastic waste Management Rules to the M/s. Enviro Recyclean Pvt. Ltd., Ramanagara vide order No. PCB/WMC-1/78/PLS/2023-24/4737, on 02.12.2023 vide ref (7) (Copy of the same is enclosed as Annexure-IV). Also, the Regional Officer, Ramanagara has been directed to calculate and recommend levy of Environmental Compensation corresponding to the quantum of EPR certificates generated not in conformity with the requirement prescribed in CPCB "Guidelines for Assessment of Environmental Compensation to be levied for violation of Plastic Waste Management Rules, 2016" after verifying the Rule as mentioned in the Guidelines for EC Assessment for violation of PWM Rules, 2016.
- 4. Directed Regional Officer-Ramanagara to take action to issue Show-Cause for debarring the unit from operating under EPR framework for a period of one year as per Clause 11.4 of the EPR guidelines under PWM Rules.
- Issued directions to the Regional SEO, Ramanagara to take immediate action to recommend the Board to issue Closure Direction as per the relevant provision of the Act.
- 6. Issued directions to all concerned Regional Officers to revisit once again Plastic waste processing units (Recyclers) No. PCB/WMC-1/77/PWM/2023-24/4176, Dt: 06.11.2023 vide ref (4). (Copy of the same is enclosed Annexure-V).
- 7. Show cause notice issued by Regional Office, Ramanagara to the industry authority vide No. KSPCB/RO-RMN/SCN/2023-24/482, dt: 05.12.2023 vide ref (8). (Copy of the same is enclosed Annexure-VI).

8. Show-Cause Notices were issued to concerned officers and the enquiry is under progress as per the provisions of law and based on the outcome of the enquiry, action shall be initiated as per Para (1) & (2) of the direction.

(3), regarding compliance of various provisions under Schedule-II of Plastic Waste Management Rules, 2016, i.e Guidelines on Extended Producer Responsibility (EPR) to the Chairman, KSPCB vide reference in respect of M/s. Enviro Recyclean Pvt. Ltd., Ramanagara, Karnataka based on the inspections carried out by CPCB on August, 30, 2023 in accordance with Clause 12.4 of the EPR guidelines (Copy enclosed). immediate action for revocation of Consent/ Authorization issued by the Board to the said industry also calculate the amount of Environmental Compensation to be levied to facilitate this Office to take further action by CPCB for cancellation of EPR registration issued under the Plastic Waste Management Rules, 2016. Action taken report shall be submitted to this Office within 03.11.2023 without fail.

The industry authorities had obtained Consent for Establishment (CFE) under Water Act and Air Act on 27.02.2023 and Consent for Operation (CFO) under Water Act on 07.03.2023 for the period upto 30.09.2032 to carryout re-processing of all types of plastic waste of capacity 3,50,000 TPA.

CPCB has developed Centralized EPR portal for registration of all Plastic Waste Processors under Plastic Waste Management Rules, 2016. Also, CPCB has developed the mechanism for generation and transfer of EPR certificates (as given in the guidance Manual developed by CPCB) by PWPs on the EPR portal and the corresponding online module of the EPR portal was launched by the CPCB.

Consequently, the industry authorities have applied for EPR registration under Plastic Waste Management Rules in CPCB centralized EPR portal on 13.03.2023. After physical verification and recommendation of RO-Ramanagara, Board has issued EPR registration through CPCB EPR portal to M/s. Enviro Recyclean Pvt. Ltd., vide reg. No. PR-25-KAR-04-AAFCE9612E-23, on dt: 25.04.2023. There after the portal will activate the function and allow PWP for certificate generation and transfer after the details of procurement of Plastic Waste details, Production and sales details of Chips, Pallet, Products, Clinker and power production details are fed into the portal.

Subsequently, the unit has started generating and transferred 3,48,500 Tonnes of EPR certificate to PIBOs which is more than the actual quantity processed and generated which is in gross violations of the provisions of EPR Guidelines.

In view of the above, CPCB has conducted a random sample audit of M/s. Enviro Recyclean Pvt Ltd, Ramanagara, Karnataka on August 30, 2023 and based on the observations, the CPCB has issued direction under Section 5 of the Environment (Protection) Act,1986 to the Chairman, Karnataka State Pollution Control Board on 26.10.2023, to take immediate following actions against the M/s. Enviro Recyclean Pvt. Ltd., Sy.No. 46/4, 46/6, 62/6 and 62/8, HallugundanahalliVillage, Harohalli Hobli, Kanakapura Taluk, Ramanagara District.

i) To suspend the consent/authorization/registration issued to unit with immediate effect and to issue show-cause notice for debarring the unit from operating under the Extended Producer Responsibility frame work for a period of One year as per clause 11.4 of the EPR Guidelines or/and for revocation of the consent/authorization/registration issued to the unit.

- ii) To levy Environmental Compensation (EC), corresponding to the quantum of EPR certificates generated not in conformity with requirement prescribed in CPCB guidance manual for operating Centralized EPR Portal. The EC is to be levied as per "Guidelines for Assessment of Environmental Compensation to be levied for violation of PWP Rules" (<a href="http://cpcb.nic.in/upload/plasticwaste/EC Regime PWM.pdf">http://cpcb.nic.in/upload/plasticwaste/EC Regime PWM.pdf</a>) and unit be directed too deposit the same in the designated Escrow Account, created by the KSPCB for the purpose.
- iii) To take necessary action against the every unit as per applicable law as the units have submitted false documents for obtaining registration as well as for generating EPR Certificates. It may further be ensured that action taken by KSPCB regarding these units should act as a deterrent for other units in committing such violations.
- iv) To take immediate necessary

Accordingly, as per the CPCB directions and as per the Hon'ble Chairman, KSPCB direction, Board has issued memo to Regional SEO and RO- Ramanagara to take immediate action for withdrawal of CTO issued to the industry on 03.11.2023. Accordingly, the Regional SEO, Ramanagara has withdrawn the Consent for Operation issued under Water and Air Act vide No. KSPCB/RSEO-RAMANAGARA/ENVIRO/ 2023-24/92, Dated 03.11.2023.

In view of the above directions by CPCB to KSPCB for revocation of registration issued under Plastic Waste Management Rules and as per the Rule 13 (10) Plastic Waste Management Rules, 2016;

State Pollution Control Board or the Pollution Control Committees shall not revoke, suspend or cancel registration without providing the opportunity of a hearing to the producer or person engaged in recycling or processing of Plastic wastes.

In order to give an opportunity, industry authorities were called for Personal Hearing on 13.11.2023. Industry authorities sent an e-mail on 13.11.2023, requesting to give a week time due to medical emergency of the director. As per the request, the hearing scheduled is postponed and re-scheduled once again on 21.11.2023.

The personal hearing was attended by the Senior Environmental Officer, Ramanagara, Environmental Officer, Regional Office, Ramanagara and Environmental Officer, WMC-1, Head Office, KSPCB, Bengaluru along with the industry authorities of M/s Enviro Recyclean Pvt. Ltd., Ramanagara represented by Sri. Rahul V. Poddar, Director and Sri. Vasanth Kumar, Additional Director.

In response to the Chair's clarification, the Senior Environmental Officer has explained that the said industry set up pertinent to land and building was ready even before

making an application for Consent For Establishment (CFE) as informed by the industry and observed during the course of inspection made on 28.2.2023. Subsequently, industry was issued with Consent For Establishment (CFE) for the reprocessing of all types of Plastic wastes of capacity 30,000 TPM with terms and conditions. Also, it was observed by the Regional Senior Environmental Officer, Ramanagara that some of the plants and machineries were already installed in the industry premises and some of the machineries were kept for installation, the presiding officer has pointed out that it is violation to keep machineries to install plants and machineries without obtaining CFE. Later, the industry authorities have an made application to the Board seeking for Consent For Operation (CFO) on 28.2.2023 and inspected the industry on 28.2.2023 and observed that plant and machineries were ready for commissioning and industry informed that plant and machineries are ready for taking trial run once the CFO is issued. The necessary electrical connections from the BESCOM and the power already granted during the course of inspection. The Effluent Treatment Plant required for treating the wash water during operation phase of the industry observed with progress and industry informed that another Seven days' time, the remaining installation and commissioning work will be completed without fail. Based on the progress and status of the industry, the consent for operation has been granted for the re-processing of all type of plastic waste of capacity 30,000 TPM with terms and conditions with a good intention to promote plastic waste recycling sector, Since there are many informal units existing and many of them could be brought under the network of consent and registration mechanism.

Further, the Hon'ble Chairman has sought for the procedure to be followed for further processing of registration procedure of PIBO and PWPs in the CPCB Centralized EPR Portal under plastic waste management Rules. The Environmental Officer of WMC-1,Board Office and also, the Nodal officer for EPR Portal under PWM Rules has explained the procedure involved in processing of registration applications of PIBOs and PWPs.

- Only after obtaining valid CFO from the Board, industry will make an application for registration in the CPCB Centralized EPR portal seeking for registration which is a pre-requisite.
- Once the application is made, this will be received by a Designated Officer (DO)-SEO-WMC1, through portal, then it will be allotted to the nodal officer for scrutiny and on ward processing of the application.
- In principal applications will be forwarded to the DO for further disposal. At this
  stage the application may either be accepted or rejected and only the
  accepted/approved applications in respect of PWPs will only be forwarded to
  Regional Officer for Physical verification.
- Further, after receipt of Physical verification report of RO,DO will process the applications and the responsibility of approval/rejection lies with the Board based on the observations.
- Activation of certificate generation process of approved PWP is based on the approval.

 Thereafter, the approved PWPs must upload plastic waste procurements details, production details, inventory and sales details which is mandate for generation of certificate.

Further, the Hon'ble Chairman sought for clarification from the Regional Officer of Ramanagara pertinent to action taken during the course of physical verification of the industry.

In response to receipt of PWP application in the Centralized EPR portal, the industry was inspected by the Regional Officer, Ramanagara along with the Deputy Environmental Officer on 27.3.2023 and the checklist and the verification details were uploaded in the portal. The details pertinent to industry were brought to the notice of the Hon'ble Chairman and also copy of the same was handed over to the Hon'ble Chairman. It was pointed out in the direction issued by the CPCB in the Paragraph of observations of made by the CPCB officials during the audit in the item 'd' as " the geo-tagged photographs/video of the plant uploaded with application are not in conformity with the actual observations during the audit, indicating that fabricated photographs had been uploaded with application. It is observed that the same was also not checked and verified during the physical verification by SPCB". For this the Hon'ble Chairman was made clear that in the physical verification conducted on 27.3.2023 by the RO, Ramanagara team, it was mentioned in the physical verification checklist in page no.3 in item Viz. Uploaded Pictures item such as "Raw Materials, Production Area, Packaging Area" was mentioned as "Not Relevant to this industry " and the same was produced before the Hon'ble Chairman. Also, the machineries details submitted by the industry were marked as 'No' in the checklist. The RO, Ramanagara has also pointed out that some of the remarks were also made in the last column about mismatching of GPS Co-ordinates, uploading of industry's sister concern pictures and also information given by the industry regarding the capacity of industry as 15,000 TPM instead 30,000 TPM in phased manner by operating industry in three shifts.

In this regard, the industry has sought for the clarification, however, since there is no provision for the applicant/industry to edit anything once it is uploaded, editing of the same could not be done as we had uploaded the pictures of the sister concern unit by oversight. Industry had submitted a letter to the RO on 2.5.2023 mentioning about these said facts and then forwarded to Board office for further needful.

The Hon'ble Chairman has sought for clarification in approving the same from WMC-1 cell even though, there are negative remarks observed by RO, Ramanagara team during the physical verification and checklist submitted to WMC-1 of the Board. Since, the DO of WMC-1 on leave, the Nodal Officer (EO,WMC-1) has clarified that, there are many informal units existing in this sector and crippling the environment, board has taken a decision to encourage and support these type of formal plastic reprocessing units and also, Karnataka state is one of the major generators of plastic waste and mismanagement in

handling of such plastic waste in the state. Also, there was an advisory direction from CPCB for facilitation of Grant of Consent to Producers/Plastic Waste Producers (PWPs) operating in MSME/Informal Sector vide Letter dated.30.12.2022. In addition to that since there is no options in editing any information pertinent change of capacity of the unit in the portal and to extend an opportunity to these type of formal units, the registration was granted with a good faith.

In the meantime, it was also brought to the notice of Hon'ble Chairman regarding the complex steps involved in portal and frequent changes happening in handling issues PIBOs and PWPs in the portal which requires some more time to understand in an effective way to carry out the processing of such applications without any hazels.

After hearing the clarifications made by the board officials, the Hon'ble Chairman expressed that the Board officials have extended an opportunity to the industry with good intentions to support an industry in a progressive way and asked for the clarification from the industry.

In response to the Hon'ble Chairman's remarks, the has submitted as follows;

- The total extent of the industry shed is approximately 50,000 sq.ft taken on rental basis which was almost completed with respect to civil works in the first week of February,2023 itself.
- The extent of land building itself is on the higher side and is one of the state of art to adopt good practices for attaining environmental governance pertinent to handling of plastic waste by procuring or installing high end machines.
- He also expressed that we are good entrepreneurs in this field from 5 decades and have intention to carry out the business in this sector even though there is a domination of informal sector.
- While making an application, the pictures uploaded in the portal were not matching
  the actual industry pictures because of the reasons that by oversight our sister
  concern photos were uploaded could not be edited, since there is not provision to edit
  till today.
- Also, mentioned that there are so many flaws and there is a complexity with respect to
  uploading of information/details in the portal, which is being faced by most of the
  recyclers and requested the respective Board to simplify the same. Else, there will be
  a more dominance of informal sectors.
- He submitted a clarification pertaining to the capacity that the attaining of the consented capacity will be in a phased manner by operating industry in 3 shifts.
- Pertinent to the EPR certificate generation, industry informed that the certificates are generated for the current year and not for the financial year 2022-23. Further, he has

requested the Hon'ble Chairman not to levy Environmental Compensation and also requested to impose one time penalty, else industry cannot survive if heavy penalty is levied in the beginning itself.

Industry requested the Board to extend an opportunity if any to process plastic waste
accumulated in the legacy waste to compensate the lapses which may be of great
benefit to local bodies and any direction issued in this regard by the Board will be
complied.

After hearing, the presiding officer has expressed that the consent for establishment and consent for operation along with EPR registration were issued by the Board with a good intention of extending an opportunity of bringing down the informal sector into the consent mechanism to follow good practices to attain the good environmental governance and also to support industries in a progressive manner.

After hearing from the both the sides, the Chairman directed as follows;

### To the Regional Officer:

- To Levy Environmental Compensation (EC), corresponding to the quantum of EPR certificates generated no in conformity with the requirement prescribed in CPCB "Guidelines for Assessment of Environmental Compensation to be levied for violation of Plastic Waste Management Rules, 2016" after verifying the Rule as mentioned in the Guidelines for EC Assessment for violation of PWM Rules, 2016.
- To issue Show-Cause for debarring the unit from operating under EPR framework for a period of one year as per Clause 11.4 of the EPR guidelines.

### To the Regional Senior Officer, Ramanagara

 To take immediate action to issue Closure Direction to the industry under Water Act and Air Act as per the law.

To SEO, WMC-1:

To take action to cancel the EPR registration issued to the industry





WHEREAS, vide ref (1) the Ministry of Environment, Forest & Climate Change (MoEF & CC) has notified Plastic Waste Management Rules, 2016, in exercise of the powers conferred under Sections 3, 6 & 25 of the Environment (Protection) Act, 1986 vide Notification No. G.S.R 320 (E) dated March 18, 2016.

WHEREAS, vide ref (2) Plastic Waste Management Rules, 2016 was amended and notified by Ministry of Environment, Forest & Climate Change (MoEF & CC) on 16<sup>th</sup> February, 2022 to insert Schedule –II, i.e. Guidelines on Extended Producer Responsibility of Plastic Packaging (hereinafter referred as "EPR Guidelines")

WHEREAS, as per Section 6.1(a) of the EPR Guidelines, "The following entities shall register on the centralized portal developed by Central Pollution Control Board namely:- (i) Producer (P); (ii) Importer (I); (iii) Brand Owner (BO), (iv) Plastic Waste Processor engaged in (a) recycling, (b) waste to energy, (c) waste to oil, and (iv) industrial composting".

WHEREAS, as per Section 11.1 of the EPR Guidelines, "All plastic waste processors shall have to register with concerned State Pollution Control Board & Pollution Control Committee in accordance with provisions of 13(3) of Plastic Waste Management Rules, 2016 on the centralized portal developed by Central Pollution Control Board.

WHEREAS, CPCB developed the Standard Operating Procedure (SOP) for registration of PWPs on March 15<sup>th</sup>, 2023 and uploaded the same on CPCB website in accordance with EPR guidelines; and

WHEREAS, as per Section 11.5 of the EPR Guidelines, "Only plastic waste processors registered under Plastic Waste Management Rules, 2016 as amended, shall provide certificate for plastic waste processing, except in case of use of plastic waste in road construction. In case where plastic waste is used in road construction the Producers, Importers & Brand-Owners shall provide a self-declaration certificate in pro forma developed by Central Pollution Control Board. The certificate provided by only registered plastic waste processors shall be considered for fulfilment of Extended Producer Responsibility obligations by Producers, Importers & Brand Owners".

WHEREAS, as per Section 11.7 of the EPR Guidelines, "The certificate for plastic packaging waste provided by registered plastic waste processors shall be in the name of registered Producers, Importers & Brand-Owners or Local authorities, as applicable, based upon agreed modalities.

WHEREAS, as per the EPR Guidelines, CPCB has developed by Centralized portal for registration of Producers, Importers & Brand-Owners (PIBOs) & Plastic Waste Processors (PWPs) that has been formally launched on April 05, 2022.

WHEREAS, CPCB has developed the mechanism for Generation Transfer of EPR Certificate (as given in the Guidance Manual developed by CPCB) by PWPs on the EPR Portal and the corresponding online module of the EPR Portal was launched on November 19<sup>th</sup>, 2022.

Further, the Regional Senior Environmental Officer(RSEO) -Ramanagara has issued Consent for Establishment (CFE) to the said industry to carryout re-processing of all types of plastic waste of capacity 30,000MT/Month vide ref (3). Subsequently Consent for Operation (CFO) was issued under the provisions of Water (Prevention and Control of Pollution) Act, 1974 vide ref (4) for the period upto 30.09.2032 to carryout re-processing of all types of plastic waste of capacity 30,000MT/Month.

As per the said guidelines, directions and after physical verification of the industry, based on the recommendation of RO-Ramanagara and in view of valid consent for operation, Board has issued EPR registration through EPR portal to the said industry vide ref(5). Later, the unit has started generating and transferred 3,48,500 Tonnes of EPR certificate to PIBOs which is more than the actual quantity processed and generated which is in gross violations of the provisions of EPR Guidelines as notified under Schedule –II of PWM Rules by MoEF & CC, CPCBs guidance manual for operating Centralized EPR Portal.

CPCB, Delhi has issued directions on 26.10.2023 vide ref (6) to the Board to suspend the Consent/ authorization/ Registration issued to the said industry with immediate effect and to issue show-cause notice for debarring the unit from operating under the Extended Producer Responsibility frame work for a period of One year as per clause 11.4 of the EPR Guidelines.

Hence, the Board issued directions to Regional SEO and RO- Ramanagara vide ref (7) to take immediate action for withdrawal of said CFO issued to the industry. Accordingly, the RSEO, Ramanagara has withdrawn the Consent for Operation issued under Water and Air Act to the said unit on 03.11.2023 vide ref(8).

As per Rule 13(10) of Plastic Waste Management Rules, 2016 and amended, an opportunity of being heard was given and the industry authorities were called for Personal hearing (PH) before the Chairman, KSPCB on 13.11.2023 vide ref (9). However the unit authority requested for a week's time to appear for PH, vide ref (10). Their request was considered and the rescheduled next date of PH was communicated to the industry authority vide ref (11).

Industry authorities attended the personal hearing on 21.11.2023 before the Chairman, KSPCB vide ref (12). After hearing the submissions made by both industry authority and the RSEO-Ramanagara and RO-Ramanagara, the Chairman viz, Presiding Officer viewed the matter seriously and instructed to levy EC after verifying the PWM Rules, to issue show cause notice for debarring the industry from operating under EPR frame work for a period of One year as per clause 11.4 of the EPR Guidelines, to take immediate action to issue closure direction to the industry under Water Act and Air Act and to take action to cancel the EPR issued to the industry under Plastic Waste Management Rules, 2016 .The proceedings of the personal hearing was communicated to the industry authorities and the Regional Officers on 28.11.2023 vide ref(13).

As per the directions issued by CPCB and in accordance with the decision taken during the Personal Hearing held on 21.11.2023 and proceedings communicated to the industry, the Board hereby revokes the EPR registration issued vide ref (5).

Hence the following order;

#### ORDER

As per Clause 6.4 of Schedule —II of the Guidelines on Extended Producer Responsibility for plastic packaging under Plastic Waste Management Rules, 2016 and as amended, the Karnataka State Pollution Control Board hereby revokes the Extended Producer Responsibility (EPR) registration issued to M/s Enviro Recyclean Pvt. Ltd. located at Sy. No. 46/4, 46/6, 62/6 and 62/8, Hallugundanahalli Village, Harohalli Hobli, Kanakapura Taluk, Ramanagara District — 562112 vide ref (5) for a period of one year for the reasons mentioned above and for gross violations of the provisions of EPR guidelines as notified under Schedule II of the Plastic Waste Management Rules with immediate effect.

The receipt of this order shall be acknowledged.

WHEREAS, vide ref (1) the Ministry of Environment, Forest & Climate Change (MoEF&CC) has notified Plastic Waste Management Rules, 2016, in exercise of the powers conferred under Sections 3, 6 & 25 of the Environment (Protection) Act, 1986 vide Notification No. G.S.R 320 (E) dated March 18, 2016.

WHEREAS, vide ref (2) Plastic Waste Management Rules, 2016 was amended and notified by Ministry of Environment, Forest & Climate Change (MoEF& CC) on 16<sup>th</sup>February, 2022 to insert Schedule –II, i.e. Guidelines on Extended Producer Responsibility of Plastic Packaging (hereinafter referred as "EPR Guidelines")

WHEREAS, as per Section 6.1(a) of the EPR Guidelines, "The following entities shall register on the centralized portal developed by Central Pollution Control Board namely:- (i) Producer (P); (ii) Importer (I); (iii) Brand Owner (BO), (iv) Plastic Waste Processor engaged in (a) recycling, (b) waste to energy, (c) waste to oil, and (iv) industrial composting".

WHEREAS, as per Section 11.1 of the EPR Guidelines, "All plastic waste processors shall have to register with concerned State Pollution Control Board & Pollution Control Committee in accordance with provisions of 13(3) of Plastic Waste Management Rules, 2016 on the centralized portal developed by Central Pollution Control Board.

WHEREAS, CPCB developed the Standard Operating Procedure (SOP) for registration of PWPs on March 15<sup>th</sup>, 2023 and uploaded the same on CPCB website in accordance with EPR guidelines; and

WHEREAS, as per Section 11.5 of the EPR Guidelines, "Only plastic waste processors registered under Plastic Waste Management Rules, 2016as amended, shall provide certificate for plastic waste processing, except in case of use of plastic waste in road construction. In case where plastic waste is used in road construction the Producers, Importers & Brand-Owners shall provide a self-declaration certificate in pro forma developed by Central Pollution Control Board. The certificate provided by only registered plastic waste processors shall be considered for fulfilment of Extended Producer Responsibility obligations by Producers, Importers & Brand Owners".

WHEREAS, as per Section 11.7 of the EPR Guidelines, "The certificate for plastic packaging waste provided by registered plastic waste processors shall be in the name of registered Producers, Importers & Brand-Owners or Local authorities, as applicable, based upon agreed modalities.

WHEREAS, as per the EPR Guidelines, CPCB has developed by Centralized portal for registration of Producers, Importers & Brand-Owners (PIBOs) & Plastic Waste Processors (PWPs) that has been formally launched on April 05, 2022.

WHEREAS, CPCB has developed the mechanism for Generation Transfer of EPR Certificate (as given in the Guidance Manual developed by CPCB) by PWPs on the EPR Portal and the corresponding online module of the EPR Portal was launched on November 19<sup>th</sup>, 2022.

Further, the Regional Senior Environmental Officer(RSEO)-Ramanagara has issued Consent for Establishment (CFE) to the said industry to carryout re-processing of all types of plastic waste of capacity 30,000MT/Monthvide ref (3). Subsequently Consent for Operation (CFO) was issued under the provisions of Water (Prevention and Control of Pollution) Act, 1974 vide ref (4) for the period upto 30.09.2032 to carryout re-processing of all types of plastic waste of capacity 30,000MT/Month.

As per the said guidelines, directions and after physical verification of the industry by the RO-Ramanagara team, wherein it was highlighted in the checklist by the RO Ramanagara team regarding the uploading of fabricated photos of the sister concern unit which was not matching with the pictures uploaded pertinent to raw materials storage area, production area and packaging area and also the plant and machineries of the industry including the GPS co ordinates of the industry which were uploaded by the industry and this office has forwarded the checklist to restrict the capacity of the unit to 15000MT/Month only Since industry himself has informed during the time of physical verification that the consented capacity of 3,60 000MTPA will be attained in a phased manner (1st and 2nd phase) and in the first phase in the interest of encouraging plastic recyclers and also to bring informal sectors in to the consent and EPR registration network mechanism.

Further, Board has issued EPR registration through EPR portal to the said industry vide ref(5) not for the recommended capacity mentioned in the checklist by the RO Ramanagara team. However Board has issued EPR registration through EPR portal for the consented capacity. And the same was verified by the CEO-2 during his visit to the industry and to Regional office Ramanagara. Later, the unit has started generating and transferred 3,48,500 Tonnes of EPR certificate to PIBOs which is more than the actual quantity processed and generated which is in gross violations of the provisions of EPR Guidelines as notified under Schedule—II of PWM Rules by MoEF& CC, CPCBs guidance manual for operating Centralized EPR Portal.

CPCB, Delhi has issued directions on 26.10.2023 vide ref (6) to the Board to suspend the Consent/ authorization/ Registration issued to the said industry with immediate effect and to issue show-cause notice for debarring the unit from operating under the Extended Producer Responsibility frame work for a period of One year as per clause 11.4 of the EPR Guidelines.

Hence, the Board issued directions to Regional SEO and RO- Ramanagara vide ref (7) to take-immediate action for withdrawal of said CFO issued to the industry. Accordingly, the RSEO, Ramanagara has withdrawn the Consent for Operation issued under Water and Air Act to the said unit on 03.11.2023 vide ref(8).

As per Rule 13(10) of Plastic Waste Management Rules, 2016 and amended, an opportunity of being heard was given and the industry authorities were called for Personal hearing (PH) before the Chairman, KSPCB on 13.11.2023 vide ref (9). However the unit authority requested for a week's time to appear for PH, vide ref (10). Their request was considered and the rescheduled next date of PH was communicated to the industry authority vide ref (11).

Industry authorities attended the personal hearing on 21.11.2023 before the Chairman, KSPCB vide ref (12). After hearing the submissions made by both industry authority and the RSEO-Ramanagara and RO-Ramanagara and the Nodal Officer of the Board, the Chairman viz, Presiding Officer viewed the matter seriously and instructed to levy EC after verifying the PWM Rules, to issue show cause notice for debarring the industry from operating under EPR frame work for a period of one year as per clause 11.4 of the EPR Guidelines, to take immediate action to issue closure direction to the industry under Water Act and Air Act and to take action to cancel the EPR issued to the industry under Plastic Waste Management Rules, 2016. The proceedings of the personal hearing was communicated to the industry authorities and the Regional Officer on 28.11.2023 vide ref(13). As per Clause 6.4 of Schedule—II of the Guidelines on Extended Producer Responsibility for plastic packaging under Plastic Waste Management Rules, 2016 and as amended and as per the proceedings of the Personal Hearing held on 21.11.2023, the Board has revoked the EPR registration issued to the industry vide ref (14).

In accordance with the decision taken during the Personal Hearing and proceedings cited at ref. (13), you are hereby called upon to Show Cause within 7 days as to why your unit shall not be debarred from operating under the Extended Producer Responsibility for a period of One year as per clause 11.4 of the EPR Guidelines issued under Plastic waste Management Rules.
